Civil War Relic Dealers and Collectors:

You are invited to attend the 32nd Annual Southeastern Civil War Show sponsored by the North Georgia Relic Hunters Association (N.G.R.H.A.). The show will be held on August 14th and 15th at the Cobb County Civic Center in Marietta, Georgia. This is a two day show which is open to the public on Saturday 9:00 am till 5:00 pm, and Sunday 9:00 am till 3:00 pm. Each year we strive to make this the best show in the country. This is the only show sponsored by the N.G.R.H.A. Our admission profits pay for the show expenses and a portion of the proceeds are donated to worthy local charitable causes.

SHOW INFORMATION RULES AND REGULATIONS

All tables are eight (8) feet long. Cost of the tables are \$55.00 for display and \$75.00 for sale. **DISPLAY TABLES ARE FOR DISPLAY ONLY. NO SALES OR ADVERTISING WILL BE ALLOWED ON DISPLAY TABLES.** There is a four (4) table maximum. Early entry is for table holders only! Dealer setup is scheduled from 1:00 pm until 7:00 pm on Friday and 7:30 am until 9:00 am on Saturday. Dealers may enter at 8:00 am on Sunday. Police Officers will be on duty every hour from 1:00 pm on Friday till 3:00 pm on Sunday. Table security is the sole responsibility of the table holder. Table covers are required and must be furnished by the table holder. Only pre-1898 items are permitted, no modern weapons or modern ammunition of any kind may be sold. This includes bottles or glassware. No Junk! This is a Civil War show and if the show committee deems something objectionable, you will be asked to remove it. Please do so immediately. If you are asked a second time, you will be asked to leave the show. Cancellations must be received no later than July 20th for a full refund. Any refunds due, will be issued one week after the show.

This is a two (2) day show. Table holders are required to stay both days unless prior arrangements have been made.

All Federal and State firearm laws must be observed.

All explosive ordinances must be inert.

The N.G.R.H.A. will not be held responsible for loss, damage or injury to assigned spaces or those holding badges at the show.

Georgia sales tax is the sole responsibility of the table holder.

BADGES

Two (2) badges will be issued per one (1) table. Additional badges can be purchased for \$15.00. There is a maximum of four (4) free badges. Badges must be worn at all times. **NO SWAPPING OF BADGES!!!!**
